

## Guidelines for Submission (Research Letters) to the JJAЕ, 2022

### 1. Qualifications of Applicant

If the authors wish to submit to JJAЕ, both the first and corresponding authors must be members of our Society in FY2021. A submission fee of 5,000 yen must be paid when submitting your manuscript.

### 2. Documents and Files for Submission (for details, see JJAЕ Guidelines for Submission, which have been uploaded on the AESJ website)

#### (1) Manuscript

1) PDF file (maximum 2MB) of the manuscript that has been written following the guidelines for submission to the JJAЕ and the detailed instructions for submission to the JJAЕ. The authors should use the template for "Manuscript of Research Letters." The formats and templates of these documents are available on the website of AESJ. Please refer to the latest instructions for submission available on the website.

2) The authors should not fill in "name," "affiliations," and "e-mail address of corresponding author." However, the lines for filling in these items should be kept empty, because the whole format will be destroyed if the lines are removed. The relevant information of the authors should be entered after the manuscript has been accepted.

3) Figures and tables must be clearly printed in black and white. Color print should not be used.

#### (2) Excel file of submission form for research letters

The authors must provide a mailing address where the corresponding author will certainly receive the invoice. The editorial board cannot take responsibility if the corresponding author does not receive the invoice for publication.

#### (3) PDF file of the proof of payment of the submission fee (5,000 yen).

### 3. Submission period: From Sunday, May 1, 2022, to 17:00 JST (sharp), Wednesday, June 1, 2022

### 5. Notice of receipt of documents for submission

The editorial board will send notice of receipt by e-mail before Friday June 3, 2022. If the author does not receive such a notice, he/she should inform the Editorial Office of the Japanese Journal of Agricultural Economics (e-mail address: [agri-eco@capi.or.jp](mailto:agri-eco@capi.or.jp)) about it.

### 6. Schedule of peer review

(1) The deadline for submission is Wednesday, June 1, 2022 (17:00 Japanese time)

(2) Notice of receipt by e-mail from The Editorial Office of the Japanese Journal of Agricultural Economics: by Friday June 3, 2022.

(3) Informing the authors of the result of the first round of the peer review: Late August, 2022 (Scheduled)

1) If accepted, the authors must submit the final version of their manuscript (MS Word and PDF) to The Editorial Office of the Japanese Journal of Agricultural Economics, by e-mail.

2) If revision is required, the authors must send the revised manuscript (PDF) and the List of Revisions for Research Letters (PDF) to The Editorial Office of the Japanese Journal of Agricultural Economics by e-mail (please enter the manuscript number as the title of the e-mail) before Friday September 23, 2022.

(4) Notice of the results of the second round peer review: Early November, 2022 (scheduled)

7. Payment of the publication fee

An accepted manuscript for publication in JJAЕ is charged as follows: 4 pages, 20,000 yen; 5 pages, 30,000 yen; 6 pages, 50,000 yen.
